AWARDS

- 1. Purpose of the Awards:** AMA launches the first edition of the AMA Architecture Madrid Awards, aimed at recognizing and highlighting the exceptional work of professionals in the fields of architecture, interior design, and design. This event is promoted by CEIDA (China Europe International Design Association) and Madrid World Capital (MWCC).
- 2. Award Candidates:** The awards are open to architects, interior designers, decorators, designers, renovators, and landscapers of any nationality. Both individuals and teams, companies, or entities may participate, provided they meet the requirements established in the call for entries.
- 3. Participation Requirements:** The awards are divided into five categories: Architecture, Interior Design, Product, People, and Brands, in which projects of any kind can be submitted. Works completed anywhere in the world are accepted, and a participant can submit as many proposals as they wish. Participation implies full and unconditional acceptance of all the rules.
- 4. Submission of Works:** The necessary documentation must be submitted through the website www.ama-award.es. The documents to be included are:
 1. Name of the architect/interior designer or studio, along with complete contact details: postal address, phone number, and email address.
 2. A brief project summary, with an explanatory text of up to 600 words describing the work.
 3. Between 5 and 8 high-resolution images in PNG or JPEG format.
 4. Photograph of the authors with a resolution of 300 dpi.
 5. A brief summary of the studio or professional presenting the project.
- 5. Awards:** Each category will have one Gold Award and two Silver Awards. Additionally, the jury may grant up to five special mentions per category, recognizing projects that stand out among the participants. Awarded projects and those receiving mentions will be published across all CEIDA and MWCC communication channels and publications. The award ceremony will be held on October 30, 2024, at the Official College of Architects of Madrid (COAM), organized by AMA.
- 6. Jury: The jury will be composed of:**

The jury will act in accordance with the contest rules and will have the following responsibilities:

1. Jointly decide and propose the winner by majority vote.
 2. The award cannot be declared void, nor can a tie be declared.
 3. The jury's decision will be final and irrevocable.
 4. The decision will be recorded in minutes, which will include the justifications for the recognition, allowing each jury member to explain their reasons separately.

7. **Schedule and Submission of Proposals:** Documentation must be submitted through the website, as indicated in point 4 of these rules. The submission deadline is October 15 at 11:59 p.m. For any inquiries, you can contact info@ama-award.es.
8. **Collaboration:** Participation in this contest implies the acceptance by all participants to cooperate with the organization of the awards and to facilitate access to media outlets wishing to interview them. The submitted material will be exempt from

reproduction rights and may be used for dissemination through publications, exhibitions, and media outlets.

9. **Protection of Personal Data:** In compliance with the General Data Protection Regulation (GDPR) of the European Parliament and Council, of April 27, 2016, the personal data of participants will be incorporated into a digital file under the responsibility of AMA. This data will not be shared with third parties, except when strictly necessary for the provision of the service, in accordance with the contest rules, or in compliance with legal obligations. By registering for these awards, participants accept these conditions and have the right to access, rectify, cancel, or oppose the processing of their data. 10. **Jurisdiction and Applicable Law:** This agreement will be governed by Spanish law. Both parties, expressly waiving any other jurisdiction that may apply, agree that any dispute, discrepancy, issue, or claim arising from the existence, validity, execution, interpretation, resolution, or termination of these legal rules shall be subject to the jurisdiction of the courts of the city of Madrid.
